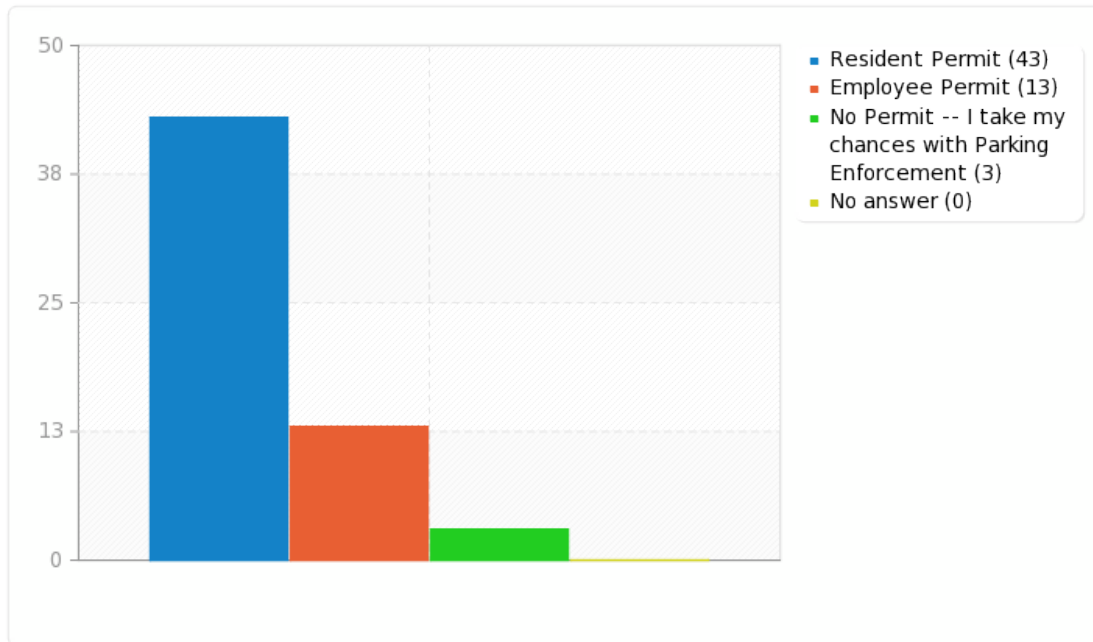

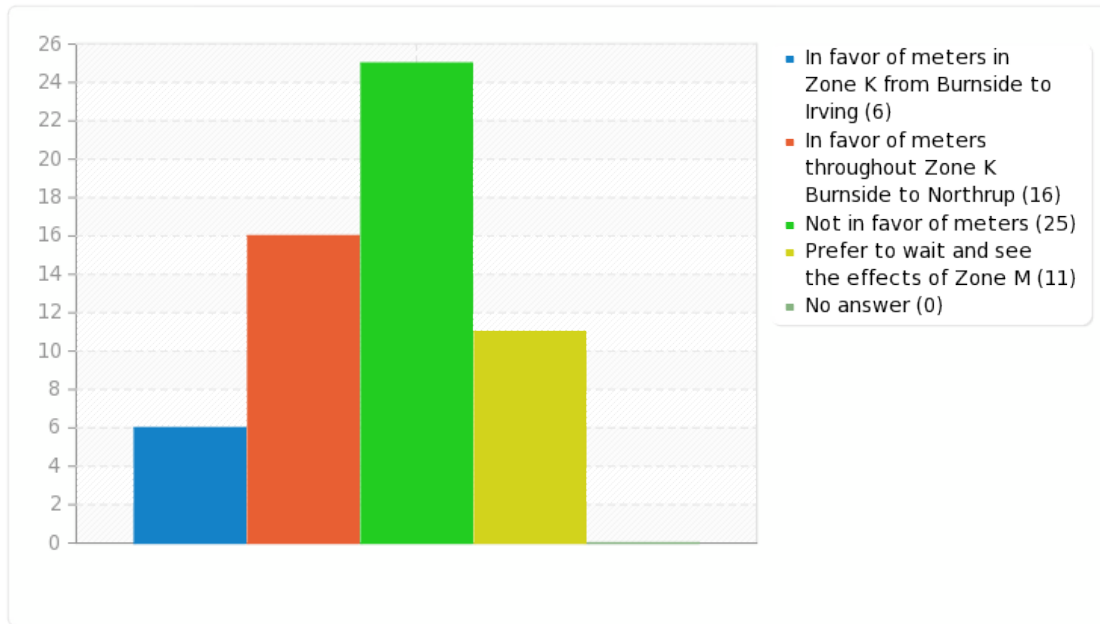

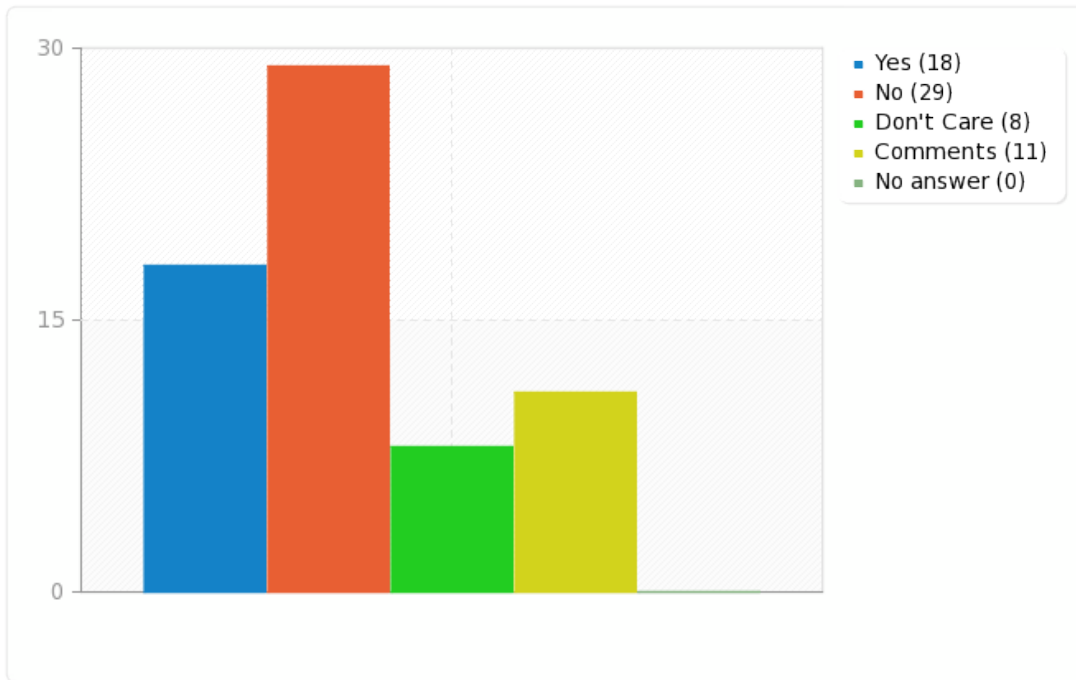

3	Guest permits are a convenience for some but may be subject to abuse.
5	I think an increase to 2 guest permits and the removal of the scratch program would be the ideal solution.
15	The scratch permits are expensive and would severely hamper my ability to host family and friends at my residence.
23	These are essential for our recording studio business clients.
36	Given that only 110 have been issued for the year and of those, some have been abused, I'd say it's not a compelling reason to continue this program.
37	This may be different needs for businesses and residents
44	I like the notion of a Plan B for any circumstances that could arise, like being able to provide a pass for a temporary move-in like a college child back for summer, a family or friend needing care, etc.
49	Guest permits are essential for residents who have company stay for extended periods of time. Though I haven't used scratch tickets, the fact that people have been selling them says that they're not working - unless that money is being given back to the Zone K committee for future use or for paying to extended the parking attendants' shifts during event nights.
50	I use single day permits for casual employees/consultant who come into the office regularly, but not more than 60 times per year. I give them a pad of single use permits and they use when they come to the office. If a employee/consultant did intend to be in the office more than 60 times per year, but was not a full time employee (according to your hourly requirements, I wouldn't want to pay more for 90 single day permits. In the end, it's a gamble if I have no consistency - which I do not - in how many people are coming into our office in any given period.
53	You need to really focus on the new residential parking needs. If you are going to permit this many new residential buildings in our neighborhood, you need to provide off-street parking for 100% of ALL residences (not just a fraction of them and forcing the rest to park on the street or use public transportation). It is jurisdictionally irresponsible to do this much new construction (business or residential) in such a dense location and NOT provide for 100% of needed parking off street. A move like that would put less pressure on area business (which can still be permitted) and their customers, and everybody would be able to park in our neighborhood.
55	There seem to be more and more day permits on cars taking up street parking; the problem is that you can't control when they are used. There is potential for abuse. PLEASE NOTE THAT THE INSTALATION OF METERS HAS ALREADY BEGUN ALONG THE WEST SIDE OF 18th ACROSS THE STREET FROM THE ZONE K AREA!!! City-contracted workers began work last week.

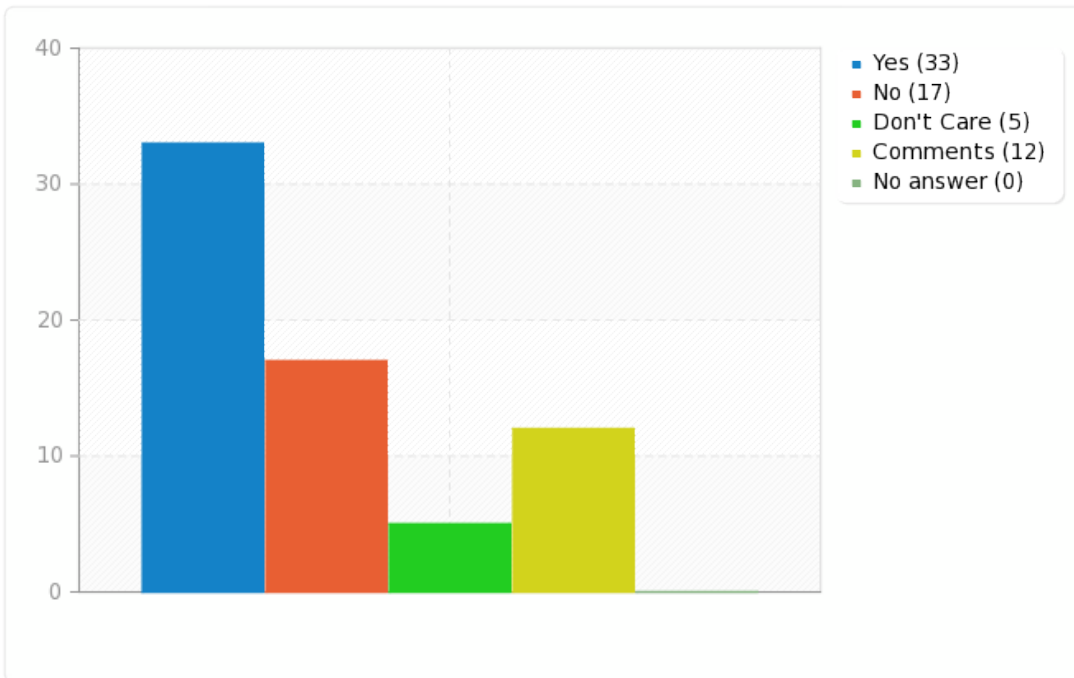

3	Scratch permits are intended for occasional guests, infrequent visitors, and home service or repair people that need parking for more than two hours. Frequent visitors or customers who need longer term parking should find other options. Scratch tickets may be subject to abuse.
5	I think an increase to 2 guest permits and the removal of the scratch program would be the ideal solution.
15	I doubt there are too many people that are abusing this system since they cost a fair amount.
23	These are essential for our recording studio business clients.
28	This would help cut down on abuses of the tickets.
31	I don't like the selling of permits; these people are screwing the rest of us who live here. I say do away with them completely as they are too easily abused. Meters are the answer with permit holders being exempt. There should be further limits to businesses. For example: a nearby local business encourages their employees to take the spots on our residential street. They are abusing our trust.
36	Eliminate the program altogether.
44	Some people don't socialize much and don't need a lot of single day scratch permits, but some people do. Some people use housecleaners every week, some people none at all. Some people pay for a handyman regularly and other repairmen to work on their home for remodeling or repairs and some people don't so much. Some people have dog walkers and sitters come to their homes regularly and others don't. It would be difficult to gauge where the limitations would be if limitations are considered. I say keep the scratch permits in bundles, as you're doing, since you make more money bundling since not all of them get used. So it's a positive for you and for residents for you to make money and encourage law-abiders and for residents to maintain their city lifestyles.
49	I think that generally they should be limited to 5 books of ten per year, and then they'd have to give an explanation in writing and get approved after that. Large businesses that have a lot of clients/workers coming through and don't have the parking to handle them should be the only ones who aren't limited, but they should provide records to prove that they need it.
50	I would say no. It is primarily small businesses which use these permits (or I would think) and these permits encourage patronage to retail locations and/or enable the businesses paying extra taxes to have a small luxury - not paying for parking!
